

## MiFID II execution venue report 2023 – portfolio management for professional clients Phoenix Asset Management Partners Limited ('PAMP')

PAMP executes client orders as part of its portfolio management services for professional clients and therefore is subject to MiFID II. This report does not include any information on execution venues used for the Phoenix UK Fund, Huginn Fund, the Aurora Investment Trust or Castelnau Group Limited as PAMP is not subject to MiFID II for these products.

MiFID II requires PAMP to publish on an annual basis, for the preceding calendar year and for each class of instrument traded, the top five execution venues it has used. In addition, PAMP must include a narrative on the quality of execution obtained from those venues.

## Execution quality report

We are careful to make sure that non 'at market' orders are executed with care so as not to impact the price. We specify that our orders are not to exceed a given percentage of the volume at that time or for the executing broker to be mindful of liquidity when executing the order.</p> |

| <p><i>(b) a description of any close links, conflicts of interests, and common ownerships with respect to any execution venues used to execute orders;</i></p>  | <p>PAMP has internal policies which detail how conflicts of interest are identified, recorded and managed.</p> <p>Treating customers fairly is central to the core values of PAMP. There is an embedded culture that understands what acceptable and unacceptable behaviour is. As such, conflicts of interest and the identification /management/ mitigation thereof are central to this philosophy and culture.</p> <p>PAMP assessed that there may be potential conflicts of interest in that our execution venues may also be investors or affiliated with investors in our products. PAMP may also use execution venues for additional services when required. All potential conflicts are logged, reviewed and managed.</p>   |
| <p><i>(c) a description of any specific arrangements with any execution venues regarding payments made or received, discounts, rebates or non-monetary benefits received;</i></p>                                     | <p>Individual agreements on commission rates are made with each execution venue.</p> <p>PAMP undertakes extensive in-house research and did not rely on its execution venues or other business relationships to provide it with external analysis. Non-monetary benefits are not accepted.</p>  |
| <p><i>(d) an explanation of the factors that led to a change in the list of execution venues listed in the firm's execution policy, if such a change occurred;</i></p>  | <p>There were no new broker relationships opened in 2023.</p>   |

For this reason, PAMP's internal policies reflect parity where investments are made across more than one client. This is also to prevent the misuse of order information by any of PAMP's staff or relevant persons.</p> <p>Therefore, if an order is made on behalf of:</p> <ul style="list-style-type: none"> <li>i) one client only, it is executed in the normal manner and the entire execution is allocated to that client;</li> <li>ii) more than one client, executions will normally be aggregated.</li> </ul> <p>PAMP ensures that:</p> <ul style="list-style-type: none"> <li>i) any aggregation of orders and transaction will not work overall to the disadvantage of any client whose order is to be aggregated; and</li> <li>ii) if an overall disadvantage has been established, it must disclose that fact to the client.</li> </ul> <p>PAMP further ensures the fair allocation of aggregated order and transactions, taking into account how the volume and price of orders determines allocations and the treatment of partial executions.</p> |
